SUMMONS

ATTENTION: DEFENDANT(S)

This is therefore to COMMAND and REQUIRE YOU to answer this Summons with the Clerk of the Magistrate Court of Walton County, Monroe, Georgia within (7) days from the date of service of the within affidavit and summons (or the first business day thereafter if the seventh day falls on Saturday, Sunday, or a legal holiday). Your answer may be filed in writing or given orally to the Judge. If you choose to file your answer orally, it must be in open Court in person and within the (7) day period. No telephone answers are permitted. If such answer is not made on or before such day, a WRIT OF POSSESSION shall issue instantly as by law provided, and a DEFAULT JUDGMENT will be taken against you for all rents demanded in said complaint, plus the costs of this action as provided by law.

The Court will schedule a hearing upon this dispossession proceeding at the Walton County Magistrate Court at a date and time to be set after your answer if filed with the Court.
