Sealed bids will be received by the Walton County Board of Commissioners no later than **2:00 p.m., Thursday, June 23, 2016**, for furnishing all materials, labor, tools, equipment, and any other miscellaneous items necessary for the Intersection Improvements West Hightower Trail at Alcovia Drive Project for the Walton County Board of Commissioners. Bids shall be marked and labeled as **Intersection Improvements West Hightower Trail at Alcovia Drive Project**. Any bid received after said time and date of bid opening will not be considered by OWNER. Bids will be publicly opened and read aloud at this time and location. All bids will be evaluated by OWNER, and the project will be awarded, if it is awarded, within sixty (60) days of the bid opening.

The Project consists of, but is not limited to the following major elements:

Construction of approximately 1,000 L.F. of road improvements, including new roundabout, roadway widening, curb and gutter, storm drainage, traffic markings, parking lot, and miscellaneous appurtenances.

Time of completion for all work associated with this project shall be ONE HUNDRED TWENTY (120) consecutive calendar days from the date of a written "Notice to Proceed" from OWNER.

OWNER requires a bid bond* or a certified cashier's check in the amount of five percent (5%) of the total bid to be enclosed with the bid at the time of bid opening. Cashier's check will be made payable to the Walton County Board of Commissioners.

OWNER requires completed E-Verify affidavit to be enclosed with the bid at the time of bid opening.

The successful bidder will be required to furnish OWNER with Insurance, Workman's Compensation Insurance, and Performance and Payment Bonds* in the amount of one-hundred percent (100%) of the total bid.

OWNER reserves the right to reject any bid based on evaluations and investigations of bidder's quality, workmanship, or adherence to schedule on previous projects. The contract shall be awarded based on the best interest of the OWNER, as determined by the OWNER.
