

July 20, 2010

The Walton County Board of Commissioners held a called meeting on Tuesday, July 20, 2010 at 1:30 p.m. in the Board Room of the Walton County Government Building, 303 South Hammond Drive, Suite 330, Monroe, Georgia. Those present included Chairman Kevin Little, Commissioners Clinton Ayers, Chuck Bagley, Vickie Gasaway, Lamar Palmer, Gerald Atha and Kirklyn Dixon, County Clerk Leta Talbird, County Attorney Kirby Atkinson, Finance Director Linda Hanna and Human Resources Director Karen Fraser.

Chairman Little called the meeting to order at 1:30 p.m.

Commissioner Bagley made a motion to adopt the agenda as presented. Commissioner Gasaway seconded the motion. All voted in favor.

Finance Officer Linda Hanna presented a resolution to set the millage rates for 2010. She stated that the County is setting the millage rates of 10.542 for the incorporated cities of Monroe, Loganville and Social Circle fire districts and 11.032 for the unincorporated areas of the County and all other incorporated areas including the Cities of Jersey, Walnut Grove, Good Hope and Between, after deducting 2.261 for the local option sales tax rollback. Ms. Hanna stated that the resolution states that the Board accepts the recommendation of the Walton County Board of Education to set the millage rates at 18.600 for the Board of Education of Walton County for school maintenance operations and 2.200 for debt service. Commissioner Bagley made a motion to adopt the resolution. Commissioner Ayers seconded the motion. All voted in favor.

Planning Director Mike Martin presented a resolution to adopt the FY 2008 and FY 2009 Capital Improvements Element Annual Update as per the requirements of the Development Impact Fee Compliance Requirements. Commissioner Gasaway made a motion to adopt the resolution. Commissioner Dixon seconded the motion; voted and carried unanimously.

At 1:34 p.m., Commissioner Bagley made a motion, seconded by Commissioner Gasaway, to adjourn the meeting. All voted in favor.
